



An Act to protect Massachusetts public health from PFAS

Chief sponsors Sen. Julian Cyr (S1356) & Rep. Kate Hogan (H2197)-
Now H4486

This bill bans PFAS in almost all products, starting with food packaging, children's products, fabric treatments, cookware, personal care products, cookware, carpets and rugs, and upholstered furniture and firefighter protective gear by Jan 1, 2026. And all other products must be PFAS free by Jan. 2030 unless granted a temporary exemption.
